WHERE EVERYDAY PEOPLE REACH OUT

Jan used her passion and skills as a designer to make a difference in people’s lives.

AN INTERIOR DESIGNER SINCE 2002, JAN BARRETT SET OUT LAST SPRING WITH FELLOW VOLUNTEER DESIGN PROS SUSAN HELLSTEDT, MISTY RIVOLI AND KELLI STRANG TO DO JUST THAT.

“We thought it would be good to pitch in and help the people around us,” she said. “The best part of this project is that it showed the girls that people in the community care about them. They saw a lot of people making an effort: the contractors, the designers, the volunteers and the Albertina Kerr staff.”

The four designers kicked off Albertina Kerr’s Youth Group Home Improvement Project with a pilot project at a group home for teen girls in Washington County. The long-term goal is to enrich the home-like environment at more than a dozen Albertina Kerr Youth Group Homes.

The volunteers chose paint colors, flooring and furniture that would create a cozy surrounding for the girls. When new bedding and linens arrived, the teens helped the designers arrange their rooms’ new set up.

So much more than a design makeover, these volunteer angels helped add to the solid, safe and nurturing home environment that Albertina Kerr provides.

YOUTH GROUP HOMES

Albertina Kerr neighborhood group homes for youth offer specialized care and treatment for children ages 7 to 18 with developmental disabilities and mental health challenges. These youth are provided with the skills they need to live as independently as possible when they reach adulthood. In addition to 24-hour supervision, there is a focus on life skill development, education, behavior management and appropriate socialization. Each individual also sets and works toward personal goals such as improving behavior and relationships.

THIS YEAR

- 15 Neighborhood youth group homes
- 102 Children served
- 92 Percent of youth that met their personal goals or are on their way

WHERE PEOPLE ARE INCLUDED AND EMPOWERED

Angie enjoys helping people as a volunteer and getting involved in her community.

A LONG-TIME RESIDENT IN A GROUP HOME FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES, ANGIE IS ALWAYS ON THE MOVE.

Her latest adventure is as a volunteer at a non-profit organization disassembling computers for recycling and reuse by others in need. After 24 hours of volunteer work, she’ll earn her own new-to-her computer. While she’s excited about the new computer, she says it makes her feel even better to help people.

“Volunteering makes me feel good. I enjoy helping people. I love it,” says Angie.

An avid reader, Angie also has a job sorting books at a recycling center. She enjoys making new friends and participating in social events such as dances at the local community center.

At Albertina Kerr, Angie has the chance to live a rich, active and meaningful life. She takes pleasure in her job and friendships. And perhaps most importantly, she has the opportunity to be a valued part of her community while giving back.

ADULT GROUP HOMES AND COMMUNITY INCLUSION PROGRAMS

Albertina Kerr operates 28 community-based residential homes that provide 24-hour service to people with developmental disabilities. The individuals served gain independence, increased choice and control over their lives with a focus on personal skill development and basic life choices as well as social and recreational activities. The Community Inclusion program also offers opportunities to participate in the workforce, community activities and hobbies that enrich their lives.

- 113 People thriving in group homes
- 112 Participants in the community inclusion program
- 92 Percent of participants in both programs working toward or have achieved their personal goals

WHERE CHILDREN HAVE REASON TO SMILE

Beth helps children emerge from crisis and get their lives back on track.

DEDICATED TO MAKING THE COMMUNITY A BETTER PLACE, BETH HAS WORKED WITH CHILDREN AND FAMILIES SINCE SHE WAS A TEENAGER HERSELF. Early on, she found her calling at Albertina Kerr and today she heads up the Crisis Psychiatric Care program.

“I want to help others find what they need to succeed day after day,” says Beth. “The best feeling comes from helping a family work through a crisis while maintaining balance and respect.”

She brings empathy to her work with families, acknowledging their experiences and helping build strength and resiliency. She sees people at their most vulnerable and distressed, and helps them through the pain and tears.

Beth is also an emerging leader who is committed to helping children and families feel connected to and supported by the community. Her collaborative approach is just one reason she was accepted as a fellow in the prestigious Robert Wood Johnson Foundation Ladder to Leadership program, an innovative course aimed at developing the future leaders of community health care.

Beth and her team are teaching children, teens and families the skills they need to stay safe, preserve relationships and be successful at home and school.

CRISIS PSYCHIATRIC CARE

Crisis Psychiatric Care (Subacute) is a short-term program (usually less than two weeks) that offers children ages 6 to 18 a safe place to stay and 24-hour access to mental health professionals to address urgent mental health crises. Children receive a psychiatric assessment, a physical health exam and individual and family therapy. The goals of the program are to stabilize children in crisis, provide effective mental health treatment and ultimately return the child to their home or a less-intense level of care.

THIS YEAR

- 314 Children and their families served
- 90 Percent of the children had decreased risk of suicide
- 83 Percent of children had decreased incidence of self-mutilation or other self-harming behaviors

WHERE FAMILIES ARE SUPPORTED

Rose and Doug offer foster children a stable, loving family with support from Albertina Kerr.

MORE THAN 15 YEARS AGO, THE COUPLE BECAME FOSTER PARENTS. Today, they are one of the first families in our new Treatment Foster Care Program for children whose mental health challenges previously limited them to residential care. Many of the children in this program have never known permanence and stability, and for Rose and Doug, that is the first step in helping them overcome challenges and succeed.

“We never give up on any of our kids,” Rose said. “A few of them have been in 15 or 16 homes, and one had a box that he never wanted to unpack because he was used to just taking the box to the next place. So I told him, ‘It’s not happening here. Unpack. You’re here now.’”

Over the years, Rose and Doug have cared for more than 30 children, staying in touch with many of them into adulthood. For them, seeing these children succeed against all odds shows them that their support has made all the difference.

FOSTER CARE

Albertina Kerr provides safe and caring homes for a wide variety of foster children in Oregon. Many have behavioral and mental health challenges as well as developmental disabilities. Families receive extensive training and a wide range of 24-hour support resources. We work closely with the child, their family, advocates, foster parents and community resources to improve the child’s ability to succeed at home, school and to reunite them with their families whenever possible.

THIS YEAR

- 126 Children served
- 67 Percent of children that exhibited antisocial behavior showed improvement
- 50 Percent of children with reported problems in school behavior showed improvement

WE'RE ALBERTINA KERR

Albertina Kerr provides a wide range of mental health services for children and support for their families. We also provide care and skills training for people with developmental disabilities, serving people in their own homes, in the community and in group home settings.

We serve individuals from all over Oregon and Southwest Washington at facilities throughout the Willamette Valley, with services primarily offered in Multnomah, Clackamas, Washington, Marion and Lane counties. We also work with foster families in Clatsop, Columbia, Tillamook, Yamhill, Polk, Lincoln, Benton and Linn counties.

SERVING OREGON FOR MORE THAN 100 YEARS

Established in 1907, Albertina Kerr has been improving the lives of Oregonians for more than 100 years. Originally a shelter for homeless men, the organization soon began offering support for women and families. Alexander Kerr, an early supporter and founder of the Kerr Glass Manufacturing Company, donated his home for use as a nursery when wife Albertina died in 1913. As the organization grew, the Old Albertina Kerr Nursery Home was built and served as a home for children until 1967. It re-opened as the volunteer-run Albertina's Restaurant and Shops in 1980. As the Fairview Training Center curtailed services in the 1970s, Kerr stepped in to provide supported living, employment and life skills training for people with developmental disabilities. Over the decades, our services have evolved to meet community needs. Today we serve children and adults with mental health challenges and developmental disabilities.

2009-10 HIGHLIGHTS

The number of people that need our services continues to grow, and during the past year we served 1,291 individuals and their families. We opened a new youth group home for adolescent girls with both mental health challenges and developmental disabilities. We also expanded our foster care program to include Treatment Foster Care for children with the most intensive mental health challenges. In addition, Albertina Kerr completed the four-year Wraparound Oregon pilot project aimed at providing a coordinated system of care for children with complex mental health needs. Today that program serves as a model of care throughout the state. Private support from people like you makes it possible for Kerr to expand capacity to meet these on-going community needs.

PROGRAMS THAT MAKE A DIFFERENCE

ADULT GROUP HOMES

Twenty-eight community-based residential homes that offer 24-hour support and individual growth opportunities to adults with developmental disabilities.

COMMUNITY INCLUSION

A program for people with developmental disabilities that gives them the opportunity to participate in the workforce, join in activities and pursue hobbies that enrich their lives, leading to increased independence and community involvement.

CRISIS PSYCHIATRIC CARE (SUBACUTE)

Short-term residential care (usually less than two weeks) and 24-hour access to mental health professionals for children with urgent mental health crises. Kerr works to stabilize children in crisis, provide effective mental health treatment and ultimately return the child to their home or a less intense level of care.

EARLY CHILDHOOD OUTPATIENT SERVICES

Assistance for pre-school children with behavioral challenges and their families. The focus is on developing skills to promote the child's success and safety, preparing them to enter kindergarten ready to learn in their local community schools. Supporters of this program include the Portland Children's Levy.

INTENSIVE COMMUNITY-BASED TREATMENT

Services for children ages 3 to 17 at risk of being unable to stay in their home or in school due to mental health challenges. In addition to help building connections within the community to develop long-term stability, the family receives home-based therapy, skills training and a 24-hour helpline.

FAMILY RESOURCE CENTER

A place for families in our community raising a child with mental health and behavioral challenges to find support, answers to questions and gather for activities and events.

FOSTER CARE

Safe and caring homes for foster children with mental health challenges as well as developmental disabilities. Parents receive extensive training and 24-hour support.

INTENSIVE TREATMENT PROGRAM

A safe and secure treatment program for youth with developmental disabilities, many of whom also have mental health challenges. This program is the only one of its kind in Oregon.

OUTPATIENT SERVICES

Mental health services for children, youth and their families provided in community settings, including homes, schools and other locations.

SUPPORTED LIVING

A support system for adults with developmental disabilities that provides opportunities to create their own living situation based on their needs and goals.

YOUTH GROUP HOMES

Fifteen group homes provide around-the-clock support and life skills training for youth ages 7 to 18 with developmental disabilities and mental health challenges that require specialized care and treatment.

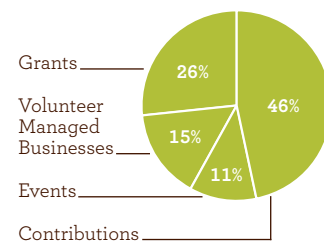

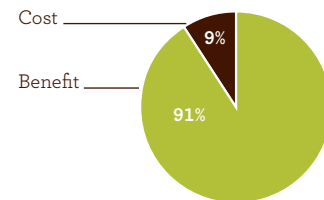

KERR GUARDIAN SOCIETY LEGACY GIFTS

We received extraordinary legacy gifts from four longtime supporters who passed away this year as well as a gift in the making for 65 years. Their gifts are invested in Kerr's endowment where proceeds will help fund future community needs.

Maybelle Clark Macdonald, 1916-2009

A longtime donor and volunteer, Maybelle "Middy" Clark MacDonald was named an honorary board member in 1993 and was proud to be a charter member of The Old Kerr Nursery Association. As her life insurance policy beneficiary, Kerr received a \$500,000 gift.

Howard N. Dietrich, 1910-2009

A lawyer, CPA and philanthropist, Howard served on Kerr's Board of Directors as Treasurer from 1962 to 1974 before becoming an emeritus member. His legacy gift will fund the next two Youth Group Home Improvement projects.

JoAnne Klaus, 1937-2009

A retired elementary school librarian, Joanne cared deeply about children and volunteered for 10 years at Kerr's Economy Jar. As the beneficiary of her retirement plan funds, Kerr received a gift of more than \$330,000.

Ada Gange, 1917-2008

A volunteer at Kerr's Economy Jar on opening day in 1981, Ada donated her time and talent until 1999. In 2003 she established a trust in which she named six charities as beneficiaries. Kerr received a gift of \$63,000 as well as Ada's household items.

Dan B. and Edith M. Jarman Trust

In 1945, Dan and Edith Jarman established a unitrust naming Kerr and two other charities as beneficiaries, leaving a legacy for three generations of family and the community. In 2010, the principal and 65 years of undistributed interest was dispersed and Kerr was fortunate to receive a bequest of nearly three million dollars.
